## Falcon Highlands Mosquito Control

- To all residents:

We wanted to update you on the mosquito control measures that are currently taking place in our community. As you may be aware, mosquitoes can be a significant nuisance during the summer months, and they can also carry dangerous diseases.

To help keep our community safe and comfortable, we have contracted with a professional pest control company to perform regular mosquito treatments. These treatments involve spraying a safe and effective insecticide that targets mosquitoes and other flying pests.

The pest control company will be conducting treatments on a regular basis throughout the summer months. The treatments will occur during off-peak hours to minimize any disruption to our residents.

While the insecticide used in the treatments is safe for humans and pets, we still recommend that you take precautions to protect yourself from mosquito bites. This includes wearing long sleeves and pants, using insect repellent, and avoiding outdoor activities during peak mosquito hours.

We also encourage you to do your part to eliminate mosquito breeding sites around your property. This includes removing any standing water, trimming overgrown vegetation, and properly maintaining your swimming pool or hot tub.

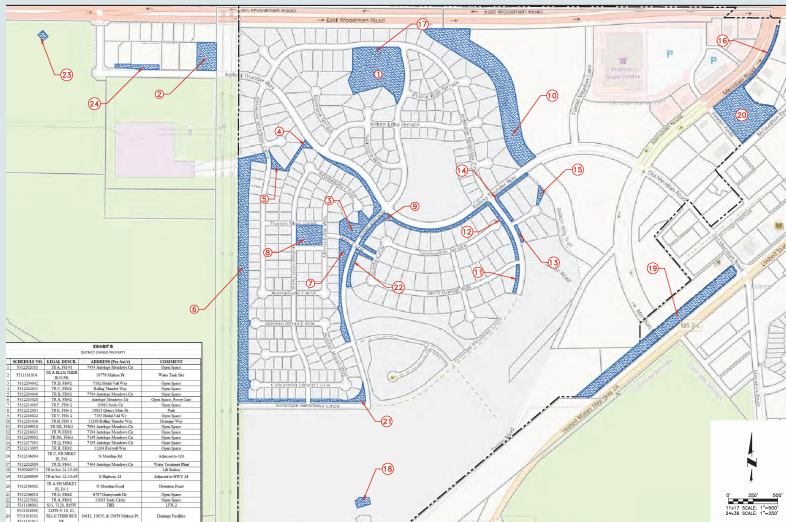
