Falcon Highlands Water Conservation Policy

Spray irrigation is limited to three days per week in accordance with the following schedule:

All customer addresses ending in an even number - Tuesday, Thursday and Sunday

All customer addresses ending in an odd number - Monday, Wednesday and Saturday

No spray irrigation is permitted on Friday

All Outdoor spray irrigation must occur between 6:00pm & 10:00am

Drip Irrigation

No limit on days, irrigable area, or frequency of use with drip irrigation

Hand Watering of Annual and Edible Plantings

No limit on days, irrigable area, or frequency of use of hand watering of annual and edible plantings; lawn watering is limited per above schedule

Personal Car Washing, Hose must be equipped with a shut-off nozzle and a bucket must be used to minimize water use

Washing of impermeable surfaces such as sidewalks & driveways is not permitted at any time

Violations of Water Conservation Policy

Violation of the District's Water Conservation Policy shall be subject to the following penalties

1st Violation - Written Warning

2nd Violation - \$100 Fine

3rd Violation - \$200 fine

4th and continued violations will result in a charge of \$300 and a suspension of service

To reinstate service a reconnection fee will need to be paid along with any outstanding violation fees and other amounts due to the District. • Reconnection fee = \$100
